**ORAL ORDER:**

Defendants' Motion to Dismiss (Doc. 8) was **GRANTED IN PART AND DENIED IN PART WITH LEAVE TO REASSERT.**

The Motion was **GRANTED** to the extent it sought dismissal of Plaintiffs' alter ego claims, and the Motion was otherwise **DENIED WITH LEAVE TO REASSERT** Defendants' arguments in a different procedural posture and on a more developed record.

Plaintiffs' claims against Defendants Steiner Education Group, Inc., Steiner U.S. Holdings, Inc., and Steiner Leisure Limited ("Steiner Defendants") were **DISMISSED WITHOUT PREJUDICE.**

Plaintiffs may seek leave to reassert their claims against the Steiner Defendants if warranted after discovery.

This action will proceed with respect to Plaintiffs' claims against Defendant FCNH, Inc., d/b/a Florida College of Natural Health.
